## **SUPPLEMENTAL MEMORANDUM OF UNDERSTANDING**

THIS SUPPLEMENTAL MEMORANDUM OF UNDERSTANDING is entered into on this the Twenty Sixth day of April, Two Thousand Twenty Five (26/04/2025):

Between:

Dr. M R GORBAL FOUNDATION, A public Charitable Trust registered under Indian Trust Act, 1882, registered on 26.08.2022 Vide Document No.337/2022-23, stored in C.D.No.BYPD1195, at the office of the Sub-Registrar, Byatarayanapura, Bangalore having its office at No.456, 3rd Cross, 4th Main, HMT Layout, Anand Nagar, Hebbal, Bangalore – 560 024, Karnataka, Represented by its President – Shri. Rameshchandra M Gorbal

(Hereinafter referred to as "**Trust**", which expression shall unless the context otherwise requires shall mean and include its successors in title and assigns).

And:

KARNATAK UNIVERSITY, University established under the Karnataka University Act, 1949, Pavate Nagar, Dharwad – 580 003, Represented by its Registrar Dr. A Channappa

(Hereinafter referred to as "**University**", which expression shall unless the context otherwise requires shall mean and include its successors in title and assigns).



The Trust and University is individually referred to as Party and collectively referred to as Parties.

**WITNESSETH AS FOLLOWS:**

- I. WHEREAS the Parties herein have entered into a Memorandum of Understanding ("MOU") dated 18/01/2023 & subsequent Office Order dated 08.02.2024 by the Registrar of the University, the Trust has agreed to implement its Schemes by way of grant of Dr. M R Gorbal studentship/scholarship/ Fellowship to the deserving students pursuing their Doctorate Degree in the Department of Physics, at the University and also grant money to bear and pay the expenses for travel and/or honorarium, cost of food, accommodation expenses for the guest faculty/expert, in the field of Physics or any field of science, for one subject-specific technical lecture per semester at the Department of Physics in the University(for brevity "Schemes").
- II. WHEREAS by way of a resolution, the Trustees of the Trust have resolved to extend the above said Schemes of the Trust, also to the Department of Chemistry in the said University in addition to the Department of Physics.
- III. Whereas on the request of the Trust, the Vice Chancellor of the University (for brevity "VC") has approved extending the Trust's Schemes to the Department of Chemistry also vide his approval.
- IV. WHEREAS in pursuance of the said approval granted by the VC the Parties, are thus desirous to amend the said MOU to implement the Schemes of the Trust also to the Department of Chemistry, Karnataka University, Dharwad in addition to



the Department of Physics also, by way of this Supplemental MOU. Hence, this Supplemental MOU.

**V. NOW THIS SUPPLEMETNAL MEMORANDUM OF  
UNDERSTANDING WITNESSETH AS FOLLOWS:**

- (1) In the said MOU, wherever the term Department of Physics/Physics Department appears, the same shall be read as "Department of Physics & Department of Chemistry of Karnataka University".
- (2) This Supplemental MOU is executed in furtherance to the said MOU dated 18.01.2023, office order dated 08.02.2024 & approval accorded by VC dated 08.04.2025.
- (3) Now with execution of this Supplemental MOU the Trust has agreed to also grant Dr. M R Gorbal studentship/scholarship/Fellowship to the deserving students pursuing their Doctorate Degree in the Department of Chemistry at the University and also grant money to bear and pay the expenses for travel and/or honorarium, cost of food, accommodation expenses for the guest faculty/expert, in the field of Chemistry or any field of Science, for one subject-specific technical lecture per semester at the Department of Chemistry also in addition to the Department of Physics.
- (4) Further the Trust may also institute a cash prize to recognise the best project report prepared by the Post Graduate students and also the best thesis submitted for awarding the doctorate degree by the research students in the Department of Chemistry and also in the Department of Physics every year.




